Please be advised that Bel-Air Owners' Committee endorsed the recommendation of Environment and Hygiene Sub-Committee at last OC meeting on 29<sup>th</sup> August 2024 regarding the additional clause of Estate House Rules with immediate effect as below:

**'13. Obstruction in Common Areas:** Occupants/Owners/Residents may not obstruct or store or leave any articles in common areas (including baby carriages, shoes, bicycles and the like). Such articles will be removed by Service Centre without prior notice and the removal and temporary storage administrative charge of removed article will be charged to the Occupants/Owners/Residents concerned.'

**'15. Keeping of Pets:** Pets are not allowed in passenger's lifts or any recreational facilities including the children's play areas, swimming pools and tennis courts. In the interest of Residents' enjoyment of the Development, please use the service lift only whenever you are with your pets. Dog must be on a leash at all times and should wear a muzzle if it is prone to bite. Owners must ensure all droppings are cleaned up, if dog keepers allow their dog to excrete on any part of the common areas, cleaning and administrative charge would be charged to the Occupants/ Owners/ Residents.'
